Clothing grants and free school meals

Application process for combined or individual rewards for up to 5 children per application.

Free school meal gives your child one free meal on every day that they are at school. Also provides payment for meals during school holidays

A clothing grant is a payment to help buy school uniforms. Qualifying families will get one grant for each child during any school year. Also provides payment during the winter to buy winter clothing.

Evidence is required to prove eligibility and can be uploaded as part of the application.

Payment is provided to applicant's bank account by BACS

What is a clothing grant?

A clothing grant is a payment made by Renfreewhire Council to qualifying parents or guardians to assist with the purchase of school uniforms. A maximum of one grant will be paid for each child during any school year.





Existing process challenges

- Face to face applications more time/travel
- Paper application to complete Waste/duplicate
- Several pieces of paper evidence to submit Insecure/easily lost
- Outdated ways of working Manual checks/errors
- High processing times Bottlenecks/Average 3 weeks
- High cost per transaction £0.18
- Slow process for treasury re BACS payments & holiday payments
- High level customer complaints




Making the payments

- Details from each application had to be transformed into a 100 character BACS code to allow for more efficient payments
- Calculations and default fields on forms used to generate majority of the BACS code
- SQL server script use to complete the BACS code and generate the payment file and accompanying ledger file based on eligibility of applicants
- Payment files transferred to treasury ePay system and payments reach applicants bank account within 48hrs
- Multiple scripts can be used to generate payment files for holiday periods and adhoc as needed
- Immediate response to failed payments




Data output

- Provide Excel reports containing views from the database for quick access to real time information
- PowerBi reports for management information which can be integrated with Microsoft Teams
- Database tables containing submission data is used for lookups to prevent duplicate applications for the same child
- Rate of application approvals dictates when payment batches are created



- 100% of applications and supporting docs submitted online
- Processing times cut from up to three weeks to two days for Clothing Grants
- Automated SEEMIS look-up improving efficiency and accuracy
- Staff handling applications has reduced by 2 FTE
- Minimal customer complaints (2022-23 school term zero complaints)
- Nominated for Cosla excellence award
- Won the Granicus award for Operational Efficiency
- Real-time management information reporting
- Automated payment files removed the need for manual BACS payments
- Transaction used to cost 18p, this has decreased to 1.2p (90% reduction)
